Our committee consisted of Donna Beck, Paula Gordos, Mary Jo Nerici, Stefani Rose, Michelle Stalnaker, and Sustainer Advisor, Cindy Spittler. We met in November to brainstorm ideas and determine our goals. We agreed on a "Baby Shark" theme with a tag line of "Spread the Word." We presented "Spread the Word... do do do do do at the November General meeting to kick off the Admissions year.

We had a second meeting to finalize details of the Open House in January. The Open House was held March 13th, 2019 at the Mentor Public Library. Previous years we held the Open House at the Lake County History Center but we moved to the library because the History Center wanted to charge us a fee this year. The library was an excellent place to hold the Open House and we recommend using it in the future. The Open House was very successful with over 20 prospective members attending.

In addition to the Open House, we had a table at the Mooreland Mansion Craft Show at Lakeland in October and we spoke to the cast of the Red Stocking Revue and had our admissions cards and WRJSL rack cards available during the 2 nights of the Red Stocking Revue. As in past years we have found that the best method for getting our name out is through our current members. Our members talking with friends, coworkers and bringing them to General Meetings is our best avenue for bringing in new members... aka "spreading the word.... do do do do do do."

As of this report, 22 applicants have submitted their applications for the 2018-2019 WRJSL year with 21 of those applicants accepting membership through paying their dues (1 dropped out because she is moving out of state and donated her dues fee and another did not pay her dues yet because she is planning on joining next year). We have an incoming class of 20 for the 2019-2020 year. The membership and admissions really rocked it out this year! Our energetic committee consists of Cathy Huffman, Pam Morse, Kathy Toderick, Carrie Lane, Becky Tuma and Sustainer Advisor Sue Ellis.

The Endowment Committee held its first organizational meeting in September to plan for the coming year. The committee goals are listed below:

- 1. Get the word out to members through general meeting, minutes and sustainers
- 2. Increase the number of "Founding 50" members
- 3. Endowment Tea planned and implemented by June 2019
- 4. Gather & finalize information on steps for planned giving
- 5. Create a newsletter send out in February 2019

The balance in the endowment fund as of June 30, 2018 was \$71,882.41.

In November 2018, Donna and Stephanie Lee met with the Cleveland Foundation to share our vision and expectations of the endowment and to listen to their ideas and, more importantly, ideas on how to grow it. The information gathered will be shared with the committee. Cleveland Foundation offers many services as part of the plan that we will be tapping into. Our immediate focus will be on the Founding 50.

With our immediate focus on the Founding 50, spreadsheets were created to document all donations to date. The entire account to date is reconciled and documented.

The Founding 50 should continue to be a focus as we work towards getting a total of 50 in this listing.

The committee wanted to introduce Endowment at every General Meeting. We want the membership to know what the Endowment means and what the Endowment can do.

At one meeting we talked about Founding 50 Facts:

In 2012, the 50th Anniversary of WRJSL, the Endowment "seed" was planted 50 was the number selected for our Heritage Leadership Level Founding Membership The \$1,000 minimum gift level was set in order to create a solid foundation for our Endowment.

We have a good start and are moving towards 50 Founding Members.

The Endowment Committee promises to wait until after Election Day to start our campaign to increase the number of Founding 50 members.

Another meeting was a skit about how **EASY** it will be to learn about our **Endowment** of the **Future**.

E – ENDOWMENT – started in 2014.

A – For **ANTICIPATION** we anticipate we will raise \$30,000 this year.

S – For **SAVING** as of June 30, 2018 we have \$71,900!

Y – For **YOU** can get involved.

IT'S EASY, Listen every month and learn more!

The next Endowment Committee meeting was held in February 2019. The committee updated the Policy & By-laws and Procedures. We decided to postpone the Endowment Tea until September as April is a busy time with Easter and preparations for this year's Follies.

The Endowment Focus for February was *Matching Funds*. As part of a corporate philanthropy programs, companies of all sizes will match donations that their employees make to charitable organizations. When an employee donates, they request a match from their employer, who then donates to the same organization. We encouraged members to check with their employers to see if Matching Funds is an option for them to donate to the Endowment Fund.

Our 4th Annual Painting with a Purpose was held at Redhawk Grille in March 2019. Proceeds benefited our Heritage Endowment Fund in the amount of \$368.62.

As of March 31, 2018, the balance was \$73,290.42. An updated amount will not be available until August. The estimated minimum balance at June 30, 2019 is \$74,159.00 (based on two deposits made after March 31).

Respectfully submitted, Pam Martin & Donna Skufca 5/30/2019 This is a comprehensive summary of the Finance area over the year July 2018 through May 2019.

Prior to 2014, the position of Treasurer included all Finance activities. During the 2015 and 2016 terms these responsibilities were shared. The Treasurer became responsible for paying all bills and deposits for membership and miscellaneous items while the Finance Chair handled the major deposits for events. The Finance Chair also headed up any check out procedures and staffing for the events.

Additionally, the Treasurer took charge of the bank recs, financial statements and the 990 plus any other committee responsibilities and the budgeting process. While this may not be maintained in the future, the workload for Treasurer is consistently on-going and having it shared (in some way) was much easier.

Key Highlights:

- Expense processing:
 - Quickbooks continues to be the method of recording deposits and writing checks for the two checking accounts for the organization. The treasurer regularly made a back-up and gave the back-up to the Finance Co-chair.
- 990:
 - The accounting firm Neece, Malec and Vitaz, who completed the previous 990 was used to complete the 2017-2018 990.
- Endowment:
 - All checks will be made to the WRJSL Heritage Endowment Fund and given to the treasurer. The treasurer records the contributions, makes copies of the checks, and forwards the check copy to the committee chair. In addition, the treasurer sends an email to both the President and Committee chair with the name of the contributor as well as the contribution amount. The Treasurer then records the contributions in our books and sends the checks to the Cleveland Foundation for deposit into the WRJSL Heritage Endowment Fund.

I also worked closely with Public Relations/Social Media, providing photos in a timely manner for posting on our Facebook site with great results.

I attended board meetings and reported on my monthly tasks and achievements.

I created a PowerPoint scrapbook showcasing the year in service league from the provisional welcome to the Red Stocking Review, which was then shown at the May dinner. I also created a version of the scrapbook for the website.

I have continued to upload photographs to our Shutterfly account. The site does not show how often these photos are then accessed or used. There are occasional comments posted by members, but not often.

A possible project would be to gather service league members to tag the photos. Maybe a small committee?

I have heard from some of our members who do not go on the site and are not on Facebook that they are disappointed they do not get to see any of the photos, except at the May dinner. I don't have a solution for this. I do include a few photos in my monthly reports which get sent to everyone.

I also worked with Mark Gifford to obtain the photographs he takes for us. He shared them with me through dropbox but that became cumbersome. Now he shares them by flashdrive. I have uploaded some of his photos to Shutterfly, but because of the size of the images, I can only upload one photo at a time so that has been a slow project.

Archiving Project

We began the process of archiving our materials, using a local archivist. I coordinated the collection of materials from service league members for this process as well as including those materials stored at Bella Donna Salon and Spa. These materials are currently in the possession of the archivist who is sorting, indexing and organizing our materials and then placing them in protective bins. This process should be completed this summer.

Once we receive the materials in an organized fashion, it would be a good time to consider digitizing and finding a home for the collection. I would recommend that we partner with a local library to host our digital archives when completed, and make them available to the public.

Any materials that did not get included can be archived in the future. A schedule should be created for collecting and archiving materials, perhaps every other year? I also recommend that we create a collection/retention policy so that we are collecting the necessary items to preserve our history.

Being historian has helped me to be an active participant in our organization and has allowed me to meet and get to know many of our members, sustainers and provisionals. I enjoyed my time as historian and look forward to serving in other capacities. Thank you for the opportunity.

Our first steps were to secure the venue and the band. Ali found Stan Davis and Bottom Line Band, a wonderful 7 piece (2 vocals) band. We were able to negotiate a lower rate with Stan for \$2,000.

We spent some time researching and visiting a few venues, but we decided to hold the Ball again at StoneWater Golf Club. Some of StoneWaters fees increased from the prior year but we were able to negotiate some of the prices down and to keep the price of the food and alcohol the same. In keeping with tradition, we choose to have the Ball on the 2nd Saturday in December.

We then began to secure our committee members and put our team together. We held a kickoff meeting in the summer at Cheryl's home. We introduced the "masquerade theme" and distributed reports from the previous year's ball chairs. We discussed colors of teal, purple, silver and gold.

The committee members worked very well together and kept us informed of their progress. We held another committee meeting in the fall at the library to check-in with the committee and to get a status report on assigned tasks. In October we had an invitation assembly party at Mary Jo Miller's home. The invitations were a beautiful black and ivory lace design. The assembly did take some time but was well worth it. We chose to forgo the printed Save the Dates and went with an electronic Save the Date designed by Elaine Barnard. The Save the Dates were sent out to our membership and used by PR to spread the word about the Ball. We recommend in the future that WRJSL maintain a database of donors/past attendees in order to keep them informed of our upcoming events. At the wrap up meeting we discussed the idea of having a WRJSL newsletter for donors so they could be informed throughout the year of the good we are doing in the community and how their donations help make it all possible.

This year's Ball had three raffles: the wine and spirit table, a gift card sleigh (over \$500 in donated gift cards), and the jewelry raffle (diamond and amethyst earring and necklace set designed and donated by W. Bill Brown). It was suggested at the wrap up meeting to add a 50/50 raffle for next year.

The decoration chairs did a wonderful job of incorporating the masquerade theme into every detail. They recommended making sure to have a contract with the florist. The place card chairs and program chairs remained flexible and detail oriented in creating beautiful place cards and programs that fit our theme perfectly.

The auction team did a great job securing some very nice items and decorating the auction room beautifully. We used ClickBid, electronic bidding. It was used at the Bag Brunch, but never before for the Ball. There was some pros and cons. The auction chairs said that there was a lot of work involved on the setup side with ClickBid and also there is a cost associated with using ClickBid, however that cost was donated this year, which is another reason why we gave it a try. Most people thought the electronic bidding was easy and fun, but there were some

individuals that did not care for it. The auction room was very empty because there was no need to place a bid on a paper sheet. Some guests mentioned that part of the fun of bidding was standing around with their friends drinking and bidding in the auction room. ClickBid did not allow individuals to see who was outbidding them which took away some of the fun of competition. However, the checkout process with ClickBid was exceptionally easy. We required guests to enter in their credit card information upon checking in to the event which allowed for quick and easy checkout at the end. We received all payments immediately at the end of the Ball. Something that has been much more difficult in previous years. We were also able to accept credit card payments for raffle tickets through ClickBid. Further discussion and consideration may be needed to see if ClickBid would be a good fit for next year's Ball.

We were fortunate to have an excellent team of ambassadors helping all of the guests throughout the night with checking in, ClickBid, and selling raffle tickets. We feel that the ambassadors were vital to the success of the Ball and we could not have done it without them.

The guest attendance was on the lower side of past years ball with 109 guests attending. At the wrap up meeting we discussed why the attendance was low. Some members suggested the time of year is not ideal with Christmas being right around the corner and it being a busy time of year. The cost of a ticket was \$165 (same as last year) and some members believe that to be too high and a deterrent in getting high attendance.

Overall the ball was a great success and we raised a profit of \$18,131,32.

We are grateful to all of the committee members, the ambassadors, everyone who donated, and to our entire membership for coming together to put on such a fabulous event.
