The Endowment Committee had our first organizational meeting on October 14th at the Mentor Public Library to plan the coming year.

The Committee met in October to plan the 2019-2020 year. The committee goals are listed below:

- The starting balance this year in The Heritage Endowment Fund as of June 30, 2019 was \$76,027.49.
- A Cleveland Foundation donation link was added to our WRJSL Website.
- Donna met with the Cleveland Foundation to partner on best ways to grow our endowment.
- Michelle Blackford from The Cleveland Foundation spoke at the General Meeting on November 21, 2019, at the TriPoint Medical Center. She spoke about the WRJSL Heritage Endowment and answering questions from our members.
 - We invited both Active & Sustainers members to the meeting.
 - We invited all 22 Founding 50 Members and more than half of them attended the general meeting.
 - There were many questions from the Placement Interviews that Michelle addressed at the general meeting.
 - o We handed out one-page summaries and had pledge cards available.
- We talked about a Campaign of growing Founding 50s, Matching Gifts, and payments on outstanding pledges.
- We discussed an **Endowment Tea** but concentrated on other avenues.
- Newsletter We discussed a spring Newsletter but with the outbreak of Covid-19, cancelled meetings and difficulty scheduling meetings a Newsletter was not possible this year.

In 2019-2020, our immediate focus was on growing the Founding 50 members. The General Meeting in November was a great informative meeting about our Heritage Endowment Fund. Hopefully, the member's questions were answered, and they have a better understanding of our Endowment into our Future!

This year we added **seven new Founding 50 members**! Carrie Lane, Diana McCubbin, Kathy Toderick, Kathy Hillard, Rita Combs, Marlene Castilyn, and Bev Lee.

The Ways & Means committee kicked off a **spring fundraiser** for the Endowment Fund - a one-week stay at the Marriott's Kauai Lagoons Kalanipu'u; November 14 - 21, 2020. Raffle Tickets were \$50 each and only 200 were available for purchase! The winning ticket will be drawn at the May Dinner. This would make \$10,000 if all tickets were sold!

With the Covid-19 pandemic of 2020, we gave members additional time to sell tickets and held the drawing on June 30th. Also, we were able to make the dates flexible which made the trip more appealing.

As of March 31, 2020, the Fund balance was \$74,434.44. An updated amount will not be available until August. The estimated minimum balance on June 30, 2020 is \$81,000. (This is based on deposits that have been made after March 31, however, more is expected depending on the amount of raffle ticket sales.)

Finance Committee

This is a comprehensive summary of the Finance area over the year July 2019 through May 2020.

During the 2015, 2016, and 2017 terms, responsibilities were shared by the Treasurer (who paid all administrative bills) and Co-Chair of Finance (who paid all major community expenses such as the Candlelight Ball, etc.) Since July 2018, the position of Treasurer has once again resumed all the duties of the Finance Chair. This includes taking charge of the bank records, financial statements and the 990 plus any other committee responsibilities and the budgeting process.

Key Highlights:

• Expense processing:

QuickBooks continues to be the method of recording deposits and writing checks for the two checking accounts for the organization. The treasurer regularly makes a back up copy of WRJSL accounting information.

990:

The accounting firm NMS, Inc. was used to complete the 990 Form for 2018-2019.

• Endowment:

All checks will be made to the WRJSL Heritage Endowment Fund and given to the treasurer. The treasurer records the contributions, makes copies of the checks, and forwards the check copy to the Endowment Committee Chair. In addition, the treasurer sends an email to both the President and Endowment Committee Chair with the name of the contributor as well as the contribution amount. The Treasurer then records the contributions in our books and sends the checks to the Cleveland Foundation for deposit into the WRJSL Heritage Endowment Fund.

Committee Activities:

- Prepared 20 Red Binders for the incoming Provisional class. Books were distributed at the Provisional Welcome dinner. Each binder contains copies of Table of Contents, Bylaws Article I- Article XI, Committee Procedures and Policies.
- At the September 2019 Board meeting, each Committee chair was asked to review their section of the Committee Policies and Procedures and determine if any changes are need. Changes are to be submitted in writing by the January Board meeting for review by Policy and By-law committee. Recommended revisions will then be presented at the March Board meeting for discussion with Final Membership vote at the April General Meeting.
- In 2019, several recommendations were received by the following Committees:
 - Active member- request to review terms of Sustainer membership voting privileges.
 - Placement committee request to revise the language of Article III, Section 3: Requirement of Membership. Item A: Outside Volunteer Placement.
 - Policy and Bylaws committee meet in January and discussed the recommendations. Committee members present were Paula Gordos, Marion Lipinski, Kristine Frankenberry, President Ame West and Sustainer Advisor Lynne Killgore.
 - Committee made a motion to Decline the request to change the terms of Sustainer Level membership. Committee stated that the current membership options of either Transitional or Active may used by any member and may be applied to each new membership year. These membership levels would allow a member more involvement in WRJSL which would also include the ability to actively vote. Changing the Sustainer membership terms would not be necessary as a result of these current options.
 - Committee Approved the request of the Placement Committee to revise
 the language of Item A in Article III, Section 3 to include more inclusive
 language to agencies in the community approved as volunteer placement
 locations. This request was then moved to the March Board meeting
 where the Board members decided to table the decision and ask the
 2020-2021 Placement committee to reevaluate the request.

Wrap-Up Committee Meeting: The Provisional Committee met on February 3rd to review the year and come up with some strategies for the future. A debriefing survey was sent prior to the meeting to gauge the success of the year. Overall, the committee felt confident that we had a great year. Also, it was determined that we need to streamline some of our practices, especially when we have larger class sizes. We also updated the Provisional Procedures.

Zoom Cocktail Hour: Because we couldn't meet in person, the Ali, Ame, the Provisionals and I had a Zoom cocktail hour to get caught up and hang out together.

In Conclusion:

This year was unusual as the two co-chairs were both new so we had to learn as we went through the year. We had a great committee though who were very supportive and that made the year go by fast.

Also unusual was that we had 20 Provisionals at the start! The class size presented some challenges – parking was sometimes an issue, and everything we did took a little bit longer. However, we made it work and had a successful season. We did have 6 of the 20 drop out so our final number was 14. Two had moved out of the area, the rest cited work and time constraints as their reasons for leaving.

We surveyed the Provisionals at the end of each meeting, switching to using SurveyMonkey rather than the paper questionnaires. An email was sent after each meeting with a link to the survey. We sometimes had to remind them to complete the surveys, but overall it was a successful way of getting responses. In addition to the link

to the survey, we also attached the agenda for the upcoming meeting and any other paperwork that was needed. The Provisionals preferred the electronic copies and it saved time at the meetings.

Another serious event was the Corona Virus pandemic, which forced the cancelation of all events for the last part of the Provisional year. Not everyone was able to attend a board meeting as required and the skit had to be postponed until we can meet again. However, the class was still promoted to Active at the Virtual May meeting.

Suggestions for the next year:

- 1. Have a separate Orientation meeting or move the "meeting" part of the Welcome to the next meeting, instead of trying to put so much information out at the Welcome.
- All handouts should be in the Red Book instead of passing them out each week.We should also start finding a way to have the materials be available online instead.
- 3. We plan to create an agenda template so that it will be easier for everyone to complete and use.
- 4. When the Gala date is changed to be earlier in the year, this will conflict with the Cocktail Party. This needs to be considered going forward.
- 5. Use Zoom or another platform to conduct meetings if stay-at-home orders are in effect.
- 6. A smaller group is preferable, especially if we are limited on how we can meet due to the pandemic.
- 7. Investigate the possibility of recording speakers to limit the number of people at each meeting.
