We, the undersigned, acting jointly as incorporators of a corporation under the Ohio non-profit corporation law and pursuant to authorization by the membership of THE WESTERN RESERVE JUNIOR SERVICE LEAGUE, an unincorporated association organized for the purposes for which a non-profit corporation could be formed, which authorization was made at a meeting of the membership duly called pursuant to the by-laws of said association, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is THE WESTERN RESERVE JUNIOR SERVICE LEAGUE, INC.

ARTICLE II

The period of its duration is for perpetual duration.

ARTICLE III

The purposes for which the corporation is organized shall be to foster interest among its members in the social, economic, educational, cultural, and civil conditions of the community and to make efficient their voluntary services.


